This announcement was made by Commissioner Sayers, acting for the city members of the Jefferson County Dental Society, who will assume the expense and management of the affair. In this work the dentists are looking toward the health of future generations by administering to the needs of the children now in the public schools. Doctors from the society will make the rounds of the schools, examining the mouths of the scholars, seeking and adopting the best means to prevent full development of the child and leads often to disease. Such growths form in the back of the mouth, hindering breathing. In the early stage they can be prevented easily. But the care of the teeth will not be neglected. If a child's parents are too poor to bear the expense of dental work, the youth will be given free treatment at clinics, to be established by the society. For this work the doctors will devote so many hours a week, each dentist giving his share. The dentists hope to get the dispensary in working order by fall. An office will be leased and all preparations made for carrying the project to a successful working state. The out-of-town members of the dental society have not been consulted in the matter, but the project has been discussed by local doctors at the meetings and a decision in favor of the dispensary has been reached. It is not in its present state, a society affair, the city members, alone, having pledged themselves to support it. While the city dentists were the approval of the board by this announcement, the doctors of medicine came in for disapproval in a communication from City Clerk C. H. Hodges, who presented to the board the complaints of the state health department relative to the incomplete death reports filed and the negligence in the registration of births. As to the births, Mr. Street says he gets them to the health department as soon as each month as he can, but at each report there are many "delayed births" that does not reach the health department promptly and calls attention to the fact that physicians have 36 hours in which to file birth certificates and 24 in which to file death certificates. the cans are washed or with which the milk is adulterated, the hands of the milker as well as his clothes, are all occasionally the source of bacterial contamination. But after all, we must look upon the cow herself as the cause of the most trouble. From the cow the bacteria gets into the milk during the milking, partly from the milk ducts, partly from the dirt that is attached to the cow. Thus the important point toward which to direct the cleanliness is the cow herself. The majority of farmers never appear to feel that it is necessary for him to keep his cows as clean as his horse. But there is very much more to be done for cleanliness in the case of the cow. Upon such cleanliness will depend his ability to obtain a pure, wholesome milk, while so sure as he allows his cow to become covered with dirt and manure so sure will he be liable to have trouble with the milk. So it is well to repeat that the first and foremost of obtaining a proper supply of milk is to have a healthy cow and to keep that cow clean, and the utensils used in the process of milking and handling of same.

**KILLS PHEASANT PAYS FINE OF \$75**

LESLIE PRATT VIOLATES STATE GAME LAW

**ANOTHER PAYS \$20 PENALTY**

Samuel Mooney Hunted Without a License and is Fined as a Result—Jefferson County Sportsmen Hold Meeting.

When Leslie Pratt of Hunt street paid Justice of the Peace Steele of Brownville \$75 for a pheasant one day last week, he discovered that the state's price for birds of this species are way above the wildest dreams of the meat trust. A good, healthy pheasant weighs about four pounds so the bird cost Leslie \$18.75 a pound. He told the justice he thought it was a partridge, but even if his thought had been borne out by the bird he wouldn't have been much better off when Game Protector F. E. Johnson of this city caught him with it, for partridge shooting is forbidden by law just at present. The shooting occurred in the town of Watertown on March 9. The killing of pheasants of any kind is forbidden in Jefferson county, where there is a perpetual closed season under the game, fish and game law, to allow the sportsmen an opportunity to replenish the coverts. Announcement of Mr. Pratt's appearance before the court at Brownville was made by Mr. Johnson at Monday night's monthly meeting of the Jefferson County Sportsmen's Association, which is endeavoring to introduce pheasants into the county. The officers of the association introduced the members that this English ring-necked pheasant has been procured and set of liberty. The association hopes to secure more of the birds. Mr. Johnson also stated that Samuel Mooney of State street has been fined \$20 for hunting without a license. Twelve new members were added to the association last evening, bringing the total membership to 447. The committee to select a club house site reported that it was looking over various suitable locations and asked for more time before completing its work and making a full report. The extension was granted. A resolution was adopted putting the association on record in favor of the bill prohibiting the sale of black bass in the state. The bill aimed at the preservation of the fish, is now before the legislature. Copies of the association's resolution will be sent Senator Cobb and the local assemblymen. At the next meeting Vice-President Frank E. Tidwell will deliver an illustrated lecture on a subject of interest to sportsmen. The topic has not been announced. The open season for trout will be inaugurated May 16.
