The bride entered the church unattended, looking very beautiful in her princess wedding gown of white silk, train, with trimmings of heavy old lace, and wearing a tulle veil with orange blossoms. WHO GOT THE MONEY?

An Interesting Analysis of the Campaign Expenditures of Senator Gates.

Continued from December 26. (Cazenovia Republican)

The would be Democratic boss of Madison county, Luke McHenry, of Chittenango, N. Y., in his papers last week again made a desperate effort to divert the attention of the people from the exposures we are making by viciously attacking one of his Republican confederates in the Democratic raid upon the Republican party last fall. We should judge that an attempt was made by Mr. McHenry, and others connected with him, sought by influence not at all elevating to the electorate, to get control of the Republican City Committee of the City of Oneida, and he now finds that the people he dealt with, in that regard, had caliber exceeding the amount that he carries around in quantity, and excelling it in quality, and the money vendors were handed a brass brick for the gold one delivered to benches of their selection. McHenry is mad. Through his clouded intellect he just sees a glimmer on the wall. He knows what is coming, and with frantic gesture he points to the Republican organization and says that the organization instigated the proceedings against Senator Gates.

The men making up the Republican organization have time and again expressed their sincere sympathy for the Senator and their extreme disgust for the money seekers who camped on his trail, among the chiefest of which was this same Luke McHenry. Our authority for this will be found in the columns of the Chittenango Times soon after election, when the editor, inflicting himself to the fullest extent that his somewhat damaged epidermis would permit, said to the public that he had no small part in bringing about the results achieved by the expenditure of over \$21,000 of the Senator's money.

Mr. McHenry cannot divert us from our purpose.

Sec. 41-n. Any person who directly or indirectly by himself or through any other person in connection with or in respect of any election:

1. Gives or provides, or causes to be given or provided, or shall pay for wholly or in part, any meat, drink, tobacco, refreshment or provision, to or for any person, other than as a part of the traveling expenses of candidates, political agents, committees and public speakers, or

2. Pays, lends or contributes, or offers or promises to pay, lend or contribute any money or other valuable consideration, for any other purpose than the following matters and service at their reasonable, bona fide and customary value, is guilty of a misdemeanor: Rent of halls and compensation of speakers, music and fireworks for public meetings, and expenses of advertising the same, together with the usual and minor expenses incident thereto. The preparation, printing and publication of posters, lithographs, banners, notices and literary material; the compensation of agents to supervise and prepare articles and advertisements in the newspapers, to examine questions of public interest bearing on the election, and report on the same; the pay of newspapers for advertisements, pictures, reading matter and additional circulation, the preparation and circulation of circular letters, pamphlets and literature bearing on the election. Rent of offices and club rooms, compensation of such clerks and agents as shall be required to manage the necessary and reasonable business of the election and of attorneys at law for actual legal services rendered in connection with the election; the preparation of lists of voters; payment of necessary personal expenses by a candidate. The reasonable traveling expenses of the committee man, agents, clerks and speakers, postage, express, telegrams and telephone; the expenses of preparing, circulating and filing a petition for nomination; compensation of poll workers or watchers, and food for the same, and election officers, hiring of carriages for conveying sick and infirm electors to the polls is guilty of a misdemeanor.

In the alphabetical list of towns DeRuyter comes next. We find the statement of Senator Gates as sworn to by him and filed with the Secretary of State discloses the following sums of money were paid to residents of that town:

In addition to the foregoing the statement shows that he had to pay \$11 for taking affidavits and copying of poll list.

What was done with this money? All of the above men are Republicans, or claim to be. Senator Gates was not on their ticket. What was this money spent for? The offense can be none the less if they took the money and put it in their pocket, and did nothing with it than if they used it illegally. In either case the imposition upon Senator Gates was disgraceful, and the effect upon the electors of the town, with their fellow citizens of the county and State was, and is, humiliating, because this money was paid for a purpose. What was the purpose? What was done with this money?

A. W. Francis is a retired feed merchant; Porter Dwight is a monument dealer; Ira Smith is an undertaker and furniture dealer. What was done with this money? I think without doubt there will be no bolting of any magnitude in this county. A prominent Republican was in the office yesterday and assured me that he hoped you would be nominated. I do not think you need be alarmed at the situation in this county, and the omission on the part of Mr. Dexter and myself to join in the Call was not due to any opposition that we have to your candidacy, and if nominated you will receive our loyal support.

ted under the law? Most of it was paid near election day. What do the people think of the men who received this money? Was it used to maintain a principle? Will the people of Madison county fall to resent an imposition upon them by another county unless they are paid exorbitant sums of money to do it?
