VETERANS' REUNION.

A Game of Lacrosse, Glass Ball Shooting, Target Shooting, Foot Racing, &c., &c.

The Veterans Reunion and Picnic at Oswego Falls yesterday was one of the greatest events of the season. At the hour announced for leaving the depot in this city a large crowd had assembled, and the train which left between 9 and 10 o'clock carried off nine cars well filled with picnickers. After reaching Fulton a procession was formed, composed of companies A and H, 48th regiment, A detachment from company F, U. S. Artillery, stationed at Fort Ontario, the Veterans Association of Oswego county and lacrosse players from the Onondaga and Onondaga tribes of Indians, headed by the 48th regiment band, and afterward joined by the Fulton company of infantry. After parading the principal streets of Fulton, the excursionists assembled on the Oswego Falls Fair Ground, where a general assault was perpetrated on lunch baskets and eating establishments generally. The afternoon was spent in a variety of field sports; first in order being the game of lacrosse between Indians of the tribes of Onondaga and Onondaga. Each side was composed of six players besides the captain. The color of the Onondaga players was blue and the names of their players were as follows: Orris Formers captain, Harvey Carpenter, Samuel Webster, Geo. Veneroy, Cornelius Johnson, Peter George and Wilson Johnson. The Onondagas had adopted red for their color, and the following were the names of their players: Elijah George, captain, Wm. Waterman, Frank Logan, Daniel George, Alex Jones, James J. Farmer and Steven Obadiah. The game was to consist of five innings, the side winning the best three out of five to be declared the conquerors. In the toss for choice of goal the Onondagas won. The game was quite exciting and considerable strength and agility were displayed on both sides. The Onondagas succeeded in obtaining one inning, the third, while the Oswegos captured the first two and the fourth, thus giving them the game. At proper intervals through the day the 48th regiment band discoursed some of their choicest selections, which was an exceedingly attractive feature of the occasion. Shortly after the lacrosse game short addresses were delivered from the judges stand by Dr. Reynolds and Rev. Daniel Tully of our city. Their remarks elicited much applause and were listened to with marked attention by the assemblage, which embraced most of the excursionists on the grounds.

After the addresses a series of sporting matches followed, consisting first of a glass ball shoot, which resulted in O. S. Osterhout taking the first prize of \$12, by a clean score of 16, breaking all the balls. On the second prize of \$8, there were four ties of 10 each, namely: E. Coe, C. Coe, Cornell and Otterson, the prize being divided proportionately, and on the third of \$5, two ties, Malbio and Betts. There was a rifle match at a target at 200 yards, open to members of infantry, for which there were twenty entries, five prizes being given, which were won by the following scores:

It is passing strange that every time Oswego people go to Fulton in any considerable numbers a disgraceful scene must be enacted on the return train. Yesterday afternoon was no exception to the rule, and the special which left Fulton for this city at half past 6 o'clock had a lot of fellows who, if they had their deserts, would be behind bars, instead of being in front of them, as most of the scamps were yesterday. Fights were frequent on the train, and the rowdies not satisfied with pummeling each other, dragged in decent people. Conductor Van Wagon was compelled to put two saucy four-monthed fellows, who refused to pay fare, off from the train due here at 9:35.
