News.

The common council meets to-night. The old D. L. & W. coal trestle is being repaired.

John DeMong was inaugurated mayor of Syracuse last night. An independent citizens' ticket will be run at the charter election in Utica.

There are three hundred and eighty-two prisoners in the Onondaga penitentiary at the present time. Kingsford's box shop, after a short close to allow the engine to be repaired, resumed work yesterday.

Mrs. Montross, mother of "Splinter" Montross, the Constantia murderer, died Friday last at Bernhardt's Bay. A lad named Hecgerly broke through the ice in the east cove yesterday, and narrowly escaped drowning.

M. E. House, who has been visiting friends in New Haven, started on his return to his home in Michigan, yesterday. A large stone fell from the cornice of Babbott's grocery, on East Bridge street, yesterday afternoon, and narrowly missed a number of persons standing in front of the store.

Mrs. William Whipple, of North Constantia, fell on the ice recently, and broke the bones of her leg in such a manner that it is feared she will be a cripple for life. Sergeant William E. Ayres, of the 24 New York cavalry wants information concerning the whereabouts of William Gore, last heard from at Battle Island in this country.

A Rochester paper says: "The trustees of Willard asylum have made their annual report for 1891 to the legislature. They report the asylum as containing 1,787 insane patients at the close of the year, a larger number of insane people than at any other institution in the world."

A Constantia couple recently called on Rev. Daniel Marvin, of Cleveland, in this county, to have him unite them in marriage. He declined on account of the youth of the would-be bride. They were subsequently united by a justice of the peace.

Eaton Branch claims that he had on his sleigh, Thursday, the biggest load of hay that was ever carried through these parts. He says that he drove on to scales what would weigh 6,000 lbs., but they couldn't weigh his load. It is estimated that he had on over 5,000 lbs. of hay.—Lake Side Press.

THE HALL MURDER CASE.

Sam. Williams Arraigned and Pleads "Not Guilty"—Jasper Newport and Courtwright Furnish the Evidence.

[Special correspondence of the MORNING EXPRESS.] LYONS, Feb. 26.—Another step has been taken toward vindicating the majesty of the law, which was so terribly outraged at Sodus Point a few weeks since, by the murder of the colored saloon keeper, James Hall. Yesterday Sam. Williams was arraigned for the crime, the grand jury having, the previous day, presented an indictment against him. He pleads not guilty. He will, in all probability, be put on trial at the May term. A very strong plank has been knocked under the feet of Williams, it is believed, by the evidence given before the grand jury by Bill Courtwright, as counsel for Williams, if report is true, depended greatly on his evidence to prove an alibi for his client. Courtwright was subjected to a long and searching examination. What that evidence was is not known, but rumor attaches great importance to it on behalf of the people. The indictment is a very strong one, and contains eight counts. Summed up, they find that Hall was killed by a club in the hands of Williams. Jasper Newport was also before the grand jury. He will be used as a witness against Williams, on the trial of the latter, and in the event of Williams being convicted, Newport will subsequently be allowed to plead guilty to a lesser offense than murder in the first degree, and thus save his neck from the gallows. Persons who saw Williams yesterday, after his arraignment, say that he was cheerful and apparently as sanguine of ultimate acquittal as ever. His counsel also, expresses his belief in his innocence, and his ability to pull his client through notwithstanding the positive testimony of Newport. In this, he differs materially from every person with whom I have conversed regarding the case, all being satisfied that Newport possesses no such heroism of character as to voluntarily accuse himself of such a heinous crime for the sole purpose of saving his brother from implication in it. Death of Charles T. Richardson.

The illness of Mr. Richardson noticed in our issue yesterday, resulted, as was expected, fatally, the sufferer passing away at 2:30 P. M. yesterday. Mr. Richardson was born near Union Springs, Cayuga county in 1832. When a young man he came to this city and entered the custom house with his uncle Jacob Richardson, at that time collector of customs at this port. Afterward deciding to adopt the profession of law, he entered the Albany law school, from which he graduated. In 1853 he was admitted to the bar of Oswego county and entered into partnership with Mr. Mason. In 1861 Mr. Richardson enlisted in the 21st N. Y. volunteers, Col. Timothy Sullivan was appointed regimental quartermaster, and served with distinction throughout the war. He afterward married Cornelia, daughter of the late Robert H. Martin, who, with three children, survives him. His principal business connections were with the firm of Richardson & Gary which continued till Mr. Gary's decease. For a few years he was alone in business but afterward became a member of the firm of Rhodes & Richardson. Mr. Richardson has at various times held the offices of cashier of the custom house, city attorney, member of the board of education and clerk of the board of supervisors, which positions he filled with honor to himself and credit to his constituents. The death of Mr. Richardson has cast a gloom over a wide circle of friends, who loved him for his many noble qualities and admired him for his abilities. As a friend he was a warm one, and his social qualities rendered him a welcome guest in society circles. His sudden taking off falls with startling effect upon this community, who can hardly realize that he has been stricken down by the grim reaper. Mrs. Richardson and daughter are expected to arrive here this morning. It will be a mournful return to them, to find the loving husband and father lying cold in death. They will have the sympathy of the entire city.

A Different View of the Case.

To the Editor of the Morning Express: I notice that you copy from the Syracuse Herald a mis-statement of the recent civil damage decision of the Court of Appeals in Mead against Stratton, reported in 25 Law Journal, 126. You say: "It has been held in the third judicial department that this statute does not cover damages to 'means of support' caused by the death of the husband, in cases where the widow brings the action." * * * The court of Appeals holds squarely that a course of action under the civil damage law does not exist under such circumstances. The plaintiff recovered judgment, and the Court of Appeals sustained it. The court says, "If the death of the deceased was a result necessarily following the intoxication, and was attributable to such intoxication, an action will be to recover the damages arising to the means of support of the plaintiff by reason thereof. Death of Ashley L. Jenne.

Ashley J. Jenne, whose dangerous illness we have announced, died Sunday night about nine o'clock. He was born in Vermont in 1808, and moved from that State to Rome, N. Y., when a young man. In 1844 he moved to the town of Oswego, where he has since lived. He was the father of Mrs. Alfred Farnham, Miss Elizabeth Jane, Henry and Theodore Jenne, Mrs. C. R. Parkinson and Mrs. Horace O. Brown. He was universally respected, and held several town offices.

RAILROAD MATTERS.

A Map of the Short Road Wanted—Railroad Improvements at Fair Haven—The Opposition to the West Shore Road—Threatened Encounter Between Railroad Employes.

The Utica Herald says that numerous inquiries have recently been made for the map showing the route of the Burt railroad thro' the county. No map has been filed as yet, altho' it is understood one has been made and forwarded to the officers of the company for examination and approval. The Fair Haven Graphic says that a new trestle is to be built at that place by the Southern Central in the place of the old one. It will be three feet higher which will permit more rapid loading of boats at the dock, and it is reported that the West Shore will make arrangements for a coal station at that point in connection with it. There is also a talk of the Jersey Central building a connection with it, for an outlet for coal. An Albany special to the Syracuse Sunday Courier says: "The contest against the West Shore and Buffalo railroad is to be vigorously pushed, and it is said that some very lively developments may be expected. Incidentally all the scandals connected with the Midland road will be dug up. Light will also be thrown upon the manner in which the West Shore road is being constructed. A number of very sensational reports are floating about, and many prominent names are mentioned. It is said when all the facts are brought out there will be many damaged reputations. All the reports are more or less vague, but the persistency with which they are circulated indicates that something is at the bottom, and that a first-class sensation may be expected in a short time." It is intimated that one official holding a high place in the state already trembles over the developments that may be made by the coming storm. Cuba, Allegany county, came near having a small railroad war last Saturday. The difficulty was between the Genesee Valley Canal railroad and the Tonawanda Valley & Cuba railroad. The latter crosses the Canal road at the south end of its 1,900 feet trestle. It is claimed by the Canal road that the trestle is not high enough for trains to run under, but as the trestle is 25 feet in the clear, the excuse does not seem to stand with railroad men. Report was rife Saturday morning that the men of the Genesee Valley Canal railroad intended to pull down the trestle and stop work. At about 10 o'clock some 75 of the Canal road men, armed with axes, spades, clubs, etc., proceeded in the direction of the trestle where they were met by an equally savage crowd of T. V. & C. men, armed in a like manner. A fight seemed imminent, but was prevented by some arrangements, which have not been made public, between the officials of both roads and the difficulty for a time smoothed over. A large number of prominent railroad men are in Cuba and things begin to look interesting.
