

WORKS DEPARTMENT HAS BUSY SESSION.

New Sidewalk Inspector Named at Meeting Held Last Night.

OBJECT TO LUMBER.

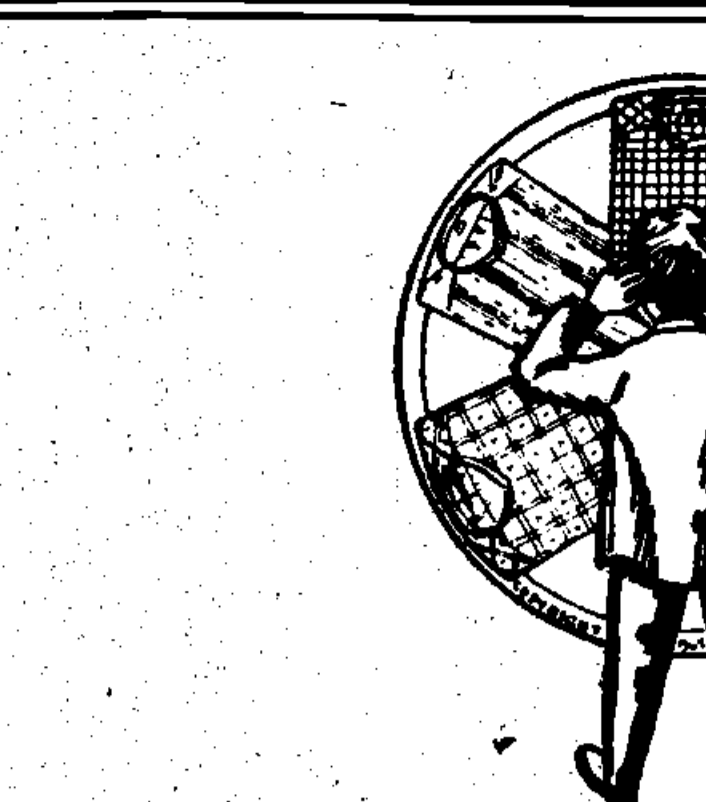
