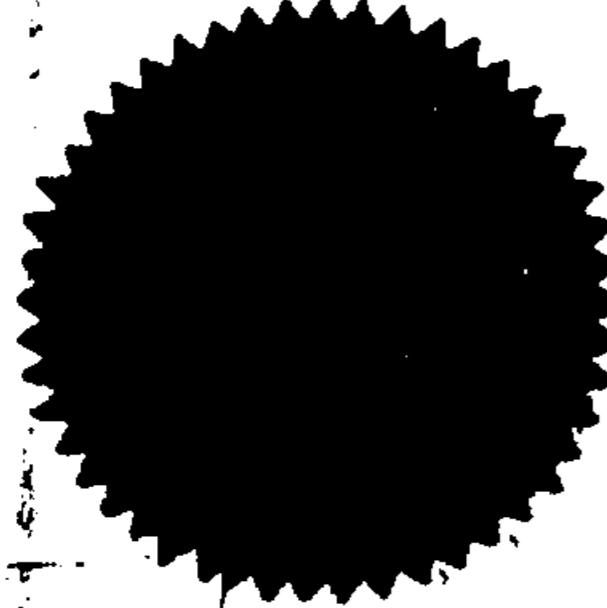

That we Edna M. Hamlin as principal of The United States Fidelity and Surety Company of Baltimore Md;

Whereas, the above bounden Edna M. Hamlin is the executrix of the estate of Josephus F. Felt, deceased

late of the city of Oswego in the County of Oswego, New York, deceased, has lately applied to the Surrogate's Court of the County of Oswego, New York, for authority to dispose, by mortgage, lease or sale, of so much of the real property of the said Josephus F. Felt, deceased, as shall be necessary to pay his debts and funeral expenses; and whereas such proceedings in due form of law have been thereupon had, that the Surrogate of said county has decreed a sale

of so much of the real property whereof the said decedent died seized, as shall be necessary to pay the debts and funeral expenses of said decedent.

Now, the Condition of this Obligation is such, that if the said Edna M.
