

LETTERS TESTAMENTARY.

To all to whom these Presents shall come or may concern, Send Greeting:

KNOW YE, That at Mexico in the County of Oswego, on the 23^d day of May A. D. 1864

before J. W. Shuman Surrogate of our said County, The last Will and Testament of James G. Jewell deceased, was proved, and is now approved and allowed by us:

LETTERS OF ADMINISTRATION.

Send Greeting:

And we do hereby these Presents, depute, constitute and appoint you, the said Maria S. Mc Ambly Administratrix of all and singular the Goods, Chattels and Credits which were of the said John Mc Ambly deceased.
