Know Ye, That at Oswego in the County of Oswego, on the 7th day of July A. D. 1864

before Timothy W. Skinner Surrogate of our said County, The last Will and Testament of James Williams deceased, was proved, and is now approved and allowed by us:

LETTERS OF ADMINISTRATION.
