

LETTERS TESTAMENTARY

The People of the State of New York,

To all to whom these Presents shall come or may concern, Greeting :-

Know ye, That at Oswego City in the County of Oswego, on the 4th day of August A. D. 1864

before J. W. Shinn Surrogate of our said County, The last Will and Testament of Virginia C. Sturges deceased, was proved, and is now approved and allowed by us: And the said Testat at or immediately previous to his death, being an inhabitant of, or having left assets which then were, or have since come within the said County of Oswego, by reason whereof the proving and registering of the said Will, and granting administration of all and singular the Goods, Chattels and Credits of the said Testat and also the auditing, allowing and final discharging the account thereof, do belong unto the Surrogate of said County: The administration of all and singular the Goods, Chattels and Credits of the said deceased and in any way concerning his Will, is granted unto James Sturges

the Executor in the said Will named, having first taken and subscribed on oath or affirmation, faithfully and honestly to discharge the duties of such Executor: hereby requiring you to make, or cause to be made, a true and perfect inventory of all and singular the Goods, Chattels and Credits of the said Testat within a reasonable time, and return a duplicate thereof to our Surrogate, of the County of Oswego, within three months from the date of these presents: and if further personal property or assets of any kind not mentioned in any inventory, that shall have been so made, shall come to your possession or knowledge, to make or cause to be made in like manner, a true and perfect inventory thereof, and return the same within two months after discovery thereof; and also to render a just and true account of the administration when thereunto required.

LETTERS OF ADMINISTRATION

The People of the State of New York,

Greeting:

And we do by these Presents, depute, constitute and appoint you, the said Smith Sturmbull

Administrator of all and singular the Goods, Chattels and Credits which were of the said Elizabeth Wade deceased.
