Know Ye, That at 16th in the County of Oswego, on the 16th day of January A. D. 1863. before Amos G. Hull Surrogate of our said County, The last Will and Testament of George S. Spear deceased, was proved, and is now approved and allowed by us: And the said Testator at or immediately previous to his death, being an inhabitant of, or having left assets which then were, or have since come within the said County of Oswego, by reason whereof the proving and registering of the said Will, and granting administration of all and singular the Goods, Chattels and Credits of the said Testator and also the auditing, allowing and final discharging the account thereof, do belong unto the Surrogate of said County: The administration of all and singular the Goods, Chattels and Credits of the said deceased and in any way concerning his Will, is granted unto George S. Greeting:
