

LETTERS TESTAMENTARY.

To all to whom these Presents shall come or may concern, Send Greeting:

Know ye, That at Pulaski in the County of Oswego, on the 14th day of February A. D. 1865 before J. W. Shuman Surrogate of our said County, The last Will and Testament of Morgan L. the Execut^r in the said Will named; having first taken and subscribed on oath or affirmation, faithfully and honestly to discharge the duties of such Execut^r: hereby requiring you to make, or cause to be made, a true and perfect inventory of all and singular the Goods, Chattels and Credits of the said Testat^r within a reasonable time, and return a duplicate thereof to our Surrogate, of the County of Oswego, within three months from the date of these presents; and if further personal property or assets of any kind not mentioned in any Inventory, that shall have been so made, shall come to your possession or knowledge, to make or cause to be made in like manner, a true and perfect Inventory thereof, and return the same within two months after discovery thereof; and also to render a just and true account of the administration when thereunto required.

LETTERS OF ADMINISTRATION.

Send Greeting:

And we do by these Presents, depute, constitute and appoint you, the said Mary S. Mills Administrat^r of all and singular the Goods, Chattels and Credits which were of the said Marlow Mills deceased.
