To all to whom these Presents shall come or may concern, Send Greeting:

Know all Men, That at Mexico in the County of Oswego, on the 6<sup>th</sup> day of March A. D. 1861

before J. W. Shinn Surrogate of our said County, The last Will and Testament of Henry C. Gale deceased, was proved, and is now approved and allowed by us:

LETTERS OF ADMINISTRATION.
