

LETTERS TESTAMENTARY.

The People of the State of New York,

To all to whom these Presents shall come or may concern, Greeting:

Know Ye, That at Oswego City in the County of Oswego, on the 2<sup>nd</sup> day of March A. D. 1865

before J. W. Shinn Surrogate of our said County, The last Will and Testament of

LETTERS OF ADMINISTRATION.

The People of the State of New York,

Greeting:

And we do by these Presents, depute, constitute and appoint you, the said JAMES HARVEY

Administrator of all and singular the Goods, Chattels and Credits which were of the said ISAAC HARVEY deceased.
