

LETTERS TESTAMENTARY.

The People of the State of New York,

To all to whom these Presents shall come or may concern, Greeting:

Know It, That at Oswego City in the County of Oswego, on the

6th day of April A. D. 1865

before Timothy Williams Surrogate of our said County, The last Will and Testament of

kind not mentioned in any Inventory, that shall have been so made, shall come to your possession or knowledge, to

make or cause to be made in like manner, a true and perfect Inventory thereof, and return the same within two

months after discovery thereof; and also to render a just and true account of the administration when thereunto re-

quired.

LETTERS OF ADMINISTRATION.
