

LETTERS TESTAMENTARY.

The People of the State of New York,

To all to whom these Presents shall come or may concern, Greeting:

Know Ye, That at the village of Chilton in the County of Oswego, on the 28th day of July A. D. 1862

before Anne G. LETTERS OF ADMINISTRATION.

The People of the State of New York,

Greeting:

Whereas Abira & Robert C. And we do by these Presents, depute, constitute and appoint you, the said Abira Landington & Robert C. Hickok Administrators of all and singular the Goods, Chattels and Credits which were of the said Abira Landington deceased.
