The People of the State of New York,

To all to whom these Presents shall come or may concern, Send Greeting:

Know ye, That at Pulaski in the County of Oswego, on the 5th day of December A. D. 1863

before J. W. Skinner Surrogate of our said County, The last Will and Testament of Simon B. Bushouse deceased, was proved, and is now approved and allowed by us:

LETTERS OF ADMINISTRATION

Send Greeting:
