Know ye, That at the village of Wesley in the County of Oswego, on the 17<sup>th</sup> day of February A. D. 1864 before J. W. the Execut<sup>or</sup> in the said Will named, her having first taken and subscribed on oath or affirmation, faithfully and honestly to discharge the duties of such Execut<sup>or</sup>: hereby requiring you to make, or cause to be made, a true and perfect inventory of all and singular the Goods, Chattels and Credits of the said Testat<sup>ment</sup> within a reasonable time, and return a duplicate thereof to our Surrogate, of the County of Oswego, within three months from the date of these presents; and if further personal property or assets of any kind not mentioned in any Inventory, that shall have been so made, shall come to your possession or knowledge, to make or cause to be made in like manner, a true and perfect Inventory thereof, and return the same within two months after discovery thereof; and also to render a just and true account of the administration when thereunto required.

LETTERS OF ADMINISTRATION

Send Greeting:
