Know ye, That at the Village of Mexico in the County of Oswego, on the 24 day of February A. D. 1864 before Timothy W. LETTERS OF ADMINISTRATION.

Send Greeting:

Whereas Malcomb J. And we do by these Presents, depute, constitute and appoint you, the said Leeman J. Mattison Administrator of all and singular the Goods, Chattels and Credits which were of the said Malcomb J. Mattison deceased.
