Whereas Asa Dudley Guardian of Adeline Farnham Addison Farnham

tition as such Guardian to Orville Robinson surrogate of the County of
Crowgo praying for an order pursuant to the revised statutes of the
State that administration of dower of Waldah Landon formerly the
wife of said Samuel be made of the lands of the said Samuel Farn-
ham deceased situate in said County & described as follows to wit
all that certain piece or parcel of land situate lying & being in the
Town of Hannibal in the County of Crowgo & bounded as follows to wit
on the west by the public highway from Crowgo village to Hannibalville
on the north by the south line of Isaac Hines land on the south
by the highway running from the Crowgo & Hannibal road to the
Crowgo River near Elijah Manns & on the east by land owned by Han-
son Dodge containing in the whole about seventy five acres being fifty
acres off of the south west corner of lot number forty & twenty five acres
off of the north west corner of lot number forty nine of the military Town-
ship of Hannibal also fifteen acres land off the north side of lot num-
ber fifty Town aforesaid & bounded as follows on the north by the
highway running from the Crowgo & Hannibal road to the Crowgo
River near Elijah Manns on the east by the road from the Fallston
Settlement to Winch's Mill on the south by land owned by William
Farnham & on the west by Smith Brown's land
And whereas the said Waldah Landon & her said husband Joseph
Landon have appeared in a court before the said surrogate held
in said County & have by their written consent filed therein con-
sent & agreed that the right of dower of the said Waldah in & to
