Hill Jr full power by these Presents to administer, and faithfully dispose of all and singular the said Goods, Chattels and Credits; to ask, demand, receive and receive the Debts which unto the said intestate, whilst living and at the time of his death, did belong; and to pay the debts which the said intestate did owe, as far as such Goods, Chattels and Credits will thereto extend and the law require; hereby requiring you to make or cause to be made, a true and perfect inventory of all and singular the Goods, Chattels and Credits of the said intestate, within a reasonable time, and return a duplicate thereof, to our County Judge of the County of Oswego, within three months from the date of these presents; and if further personal property or effects of any kind not mentioned in any inventory, that shall have been so made, shall come to your possession or knowledge, to make or cause to be made, in like manner, a true and perfect inventory thereof, within two months after discovery thereof.

And we do by these presents, delegate, constitute and appoint you the said Sally Rockwood and David S. Hill Jr

Administrators of all and singular the goods, chattels and credits of the said Warren Rockwood
