

At a term of the Surrogate's Court held at Rhine, in the County of Lewis in the aforesaid County, Dec 31/1892. Present, Wm. D. Davis, Surrogate.

Surrogate's Court Lewis County

In the matter of the final and judicial settlement of the estate of Dorcas A. Conde, deceased - the last will & testament of the said deceased.

Dorcas A. Conde, deceased

Wm. Conde the sole executor of the last will and testament of Dorcas A. Conde, deceased, having heretofore duly made application to the Surrogate of the County of Lewis for a judicial & final settlement of his accounts as such executor and all persons persons interested in the estate of the deceased consenting thereto, and waiving the service of the citation herein & requiring that an order be granted herein discharging said executor & for distribution therein prayed for, & ratifying and confirming the act & the allegation in said petition and account stated, and the said executor having rendered his account under oath before said Surrogate & the said account having been duly filed, & no objections having been made thereto, & the said Surrogate after having examined the said account, and the consent of all persons interested in said estate now finds the state & condition of the said account to be as stated and set forth in the following summary statement thereof made by the said Surrogate as finally settled and adjudged by him to be recorded with & taken to be a part of the decree in this matter, to wit -

A summary statement of the account of Wm. Conde executor aforesaid, made by the Surrogate as finally settled & allowed.

The said executor is chargeable for amounts received by him \$36,500.17 which amount he has paid out and accounted for.

And it appearing that the property remaining in hand as appears by said schedule except the sum of \$337.50 has been already divided among the parties heirs to their mutual satisfaction, and that said executor has fully accounted for all moneys & property of the estate of the said deceased which have come into his hands & that said account having been audited by the said Surrogate in a summary statement of the same having been made in & above and herewith recorded, it is hereby ordered, adjudged & decreed that the said account be & the same is hereby finally & judicially allowed & filed & adjudged.

And it is further ordered, adjudged & decreed that out of the balance of \$337.50 which is the only amount remaining in the hands of said executor except (only the trust fund herein after mentioned) that he pay to the attorney for the petitioner herein the sum of \$37.50 for the expenses and disbursements of this accounting.

And it is further ordered that he retain personally out of said balance remaining in his hands of \$300 the sum of \$100 and that he pay to Frederick L. and Marion A. Conde the sum of \$100 each.

And it is here further ordered that he upon so doing be discharged as executor of said last will & testament of Dorcas A. Conde deceased, & freed of & from all responsibility to any person interested in said will or account of his acts and omissions thereunder, without prejudice however to the execution of the trusts created in and by said will & in the 4th item thereof as hereinafter provided.

And it appearing that the said executor Wm. Conde has invested the sum of \$6000.00 as provided in & by the 4th item of the said will as trustee and in trust for Henry Davis Van Slyke Josephine Conde Mary Slyke & Marion Conde
