Surrogate Court Oswego County  
In the matter of the guardianship of Margaret C. Lovjoy and Sarah M. Lovjoy

On reading & filing the petition of Catherine V. D. Dowd of the County of Oswego & State of New York, wherein it appears that Sept. 25<sup>th</sup> 1884 Amy B. Lovjoy was duly appointed the guardian of the above named infants, upon such appointment duly filed a bond executed by George B. Sloan and Geo. C. Cook both of Oswego N.Y. as sureties that thereafter said guardian intermarried with one John Bull on the 30<sup>th</sup> day of September, 1891 departed this life having first duly made her last will and testament, which has been duly proved & admitted to probate wherein whereby the said Catherine V. D. Dowd was appointed, the said executor & she duly qualified as such and whereas there appears to be in her hands at this time the sum of \$12571.13 of money and securities belonging to said infants and it appearing that in & by the will of said Amelia Bull one Leander H. Hammon was duly appointed guardian of said infants & has duly qualified and now acts as such and the said infants having personally appeared in Court this day and Geo. T. Clark having been duly appointed special guardian to protect their interests thereon and it appearing that the said executor is desirous of handing over the money and securities belonging to said infants to the said guardian appointed

by said will, and to be released and discharged from any further obligation in respect thereto, that the bondmen of said Amelia B. Bull be likewise discharged, and the said executor having rendered an account under oath before said surrogate, with said account having been duly filed and no objection having been made thereto, and the said surrogate having examined said account, now here finds the state and condition of said account to be as set forth in the following summary statement thereof, made by the said surrogate as judicially settled & adjusted by him to be recorded with & taken to be part of the decree in this matter to wit

Summary Statement

The said executor Amelia B. Bull as guardian is to be charged with the balance on hand as per account rendered January 12<sup>th</sup> 1887. \$12,251.15  
and with the increase thereon amounting in all to the sum of \$15,587.88  
that there is to be deducted from said last mentioned sum for disbursements made for said infants as per schedule "B" & C filed with the petition herein as follows viz -  
For Sarah M. Lovjoy \$1171.23  
For Margaret C. Lovjoy 2145.52  
Amounting in all to 3316.75 3316.75  
which leaves a balance in cash securities now in the hands of said executor of \$12,571.13  
which is invested as follows viz -  
In Western mortgages 9466.  
In Canada Southern Bonds 2000.  
In Oswego City Savings Bank 920.61  
Balance in hands of executor 1845.2  
\$12571.13
