Henderson of Mayville, Dodge County
Wisconsin I give and bequeath two feather
beds, four bed comforters - four pillows
four bed blankets, four bed quilts - bandel
China tea set - my trunk and contents -
and clothing not hereinbefore bequeathed
my silver ware, my gold watch & chain.

All these articles to be packed safely
packed and sent to my niece Mrs. Jane
Henderson and I bequeath to her the sum
of five hundred dollars in money.

With

I give and bequeath my buggy & single
harness and all of the rest residue remainder
of my house hold furniture to Eliza
Handigo, Judson H. Reed and
Charles Reed, to be divided equally
between them share and share
alike - and if they cannot agree upon
division my executor hereinafter named
authorized to sell the same and divide
the proceeds.

In case my property at the time of my
death shall be insufficient to pay the foregoing
money legacies in full, then the same shall
be paid pro rata and neither of said beques-
ts shall have precedence or priority over any other.
Lastly - I hereby authorize and direct my
executor hereinafter named, to sell dispose
& convey all of the real estate of which I may

die seized or possessed, at such time
and upon such terms, in such manner as
to him shall seem meet and proper and
out of the avails thereof, or so much thereof as may
be necessary pay & discharge the debts bequests
and legacies aforesaid & the rest residue
and remainder thereof & the rest residue
remainder of all my property of every name and
nature after the payment of my debts funeral
expenses and legacies aforesaid I give & bequeath
to the said Jane Reed, Lucinda Branch,
Robt. Maddox Eliza Handigo, Judson H. Reed
and Charles Reed and William E. Poucher
severally in the proportion that the foregoing
money bequests to them respectively bear to
each other.

Likewise I make constitute & appoint
William E. Poucher of the City of Oswego New York to be
my executor of this my last will & testament, hereby
revoking all former wills by me made.
