Fuller late of the City of Oswego in the County of Oswego, and State of New York, deceased. And these deponents do further say, that the said Elizabeth A. Fuller deceased, did, in the presence of each of these deponents, subscribe her name at the end of the instrument in writing which is now here shown to these deponents, and which purports to be the last Will and Testament of the said deceased, and which bears date on the 30th day of March one thousand eight hundred and 92.
