First - After all my lawful debts are paid & discharged, I give & bequeath unto my husband William Wright & to my brother James Wright a comfortable support & maintenance & decent burial from the real income (& principal if need be) of my estate real personal & mixed during their natural life & the life of the survivor of them.

Second - After the decease of my said husband my said Brother I give & demise unto my nephew Fred Martin ten acres off from the farm in Granby Va. now occupied by me to be laid off from the East side of said farm being the part fronting on the East road & including the buildings & running back far enough to make ten acres of land.

Third - After the death & residue & remainder of my estate I give & bequeath unto Sarah Ann James Elizabeth Martin, Ella Edgerton, Carrie Cameron James Martin & Fred Martin & Theresa Wright share & share alike.

Fourth - It is my will that my husband & brother reside upon & occupy the farm of 60 acres the same as now occupied by me, so long as they shall be able & desire to work the same, & if from extreme old age sickness or other infirmities they should not be able to live upon & care for said farm & it should seem desirable to my executor hereinafter named to lease or sell said farm or any part thereof, then & in such case & with the approval of the Surrogate of Denys Co. Va. I hereby authorize & empower my said executor to see & convey the same & from the proceeds of the same & from my personal estate provide for my said husband & brother as above specified & in case of such sale then the value of said demise to Fred Martin shall be paid to him in money, if so much remain at the decease of my said husband & brother such value to be determined by three appraisers at the time of sale to be appointed by the Surrogate of Denys Co. Va. such appraisal to be filed in his office.

Likewise I make constitute & appoint my friend & neighbor Moses Johnson to be sole executor of this
