 bushels of Buckwheat to my daughter Betty. Lastly I give
 and bequeath all my remaining personal property of what
 nature or kind soever to my said Charles for his use and
 benefit forever and the said Charles hereby signified in
 consideration of the premises to pay all debts due and
 demand against me or my said estate of any description

 ecutors of this my last Will and Testament, hereby revoking
