In the name of God Amen I Rufus B. Rockway of the County
Polk in the County of Polk State of Kentucky being of
Sound Mind and Memory but weak in body do make
and publish this my last Will and Testament as follows
Item I first give and bequeath to my wife Mary three
hundred Dollars to be paid by my son Rufus B. Rockway
in lieu of her dower to be paid to her as she may want
for her support, and in case she should die without making
any disposition of the said sum, or balance that may be
at the time of her decease, then the same or so much as may
remain due shall be equally divided among my children
But she my said wife shall have full power to dispose of
the same or any part of it by Will or otherwise as she may
choose, but the balance of the said three hundred Dollars
remaining due if any then be at the time of her death
my said son Rufus shall have five years in which to pay
it I also give her absolutely to her own disposal all my
household furniture also the grain that may be growing
on my land and the wool on the sheep at the time of my
death I also give her during her natural life the way
run Com. as provided and kept for her use by my son
Rufus I also will that she have the right of living during
her life in the house now occupied by me the said Rufus

to be at her disposal at the time of her death
Item second I give and bequeath to my son Rufus
all my real estate, whether my claim to the same be by
Deed or contract, together with all my personal prop-
erty except as otherwise provided for in this my testament
upon condition of his paying the several sums which are
demanded for him to pay to my wife Mary and my other chil-
dren the said real estate to go to him or her simple
Item third I give and bequeath to my daughter Charlotte
the wife of Jack Wright the sum of twenty dollars to be paid
by my son Rufus within five years after the time of my
death without interest on the same as herein after provided
Item fourth I give and bequeath to my daughter Susanah the
wife of George Farley the sum of fifty dollars to be paid in
five years after my death without interest by my said son
Rufus as herein after provided
Item fifth I give and bequeath to my daughter Mary the widow
of Samuel Green the sum of fifty dollars to be paid by my son
Rufus in five years after my death without interest as here-
in after provided
Item sixth I give and bequeath to my daughter Betty the wife of
William Wyles the sum of thirty dollars to be paid by my son Rufus
in five years after my death without interest as here-
in after provided
Item seventh I give and bequeath to my daughter Sarah Beville
Wray the sum of sixty dollars to be paid by my son Rufus
in five years after my death without interest as herein
after provided
Item eighth I will that the said legacies be paid by
my son Rufus in grain stock or produce or Money at his
election at such time and whenever he may elect to pay
the same within the time limited in the above bequests to my
said daughters my son Rufus is also to pay all my debts
Item ninth I hereby constitute and appoint my son Rufus
