I further give and devise to my daughter Sally
Abraham and to my Grand daughter Phenomena
Robinson the one fourth each & to Lois Waller and
Esther Barber my two eldest daughters one eighth
each their heirs and assigns forever the residue
& remainder of the said lot number thirty seven
in Township number twenty one of Scribner's pa-
tent situate in the Town County & State aforesaid
I further give and devise to my daughter Sally
Abraham her heirs & assigns forever the North west
corner of Lot number sixty four in the Twenty
first Township of Scribner's Patent situate in the Town
of Richland County of Oswego & State of New York
containing twenty five acres. I further give and
devise to my son Benona Bennett all that
certain piece or parcel of land situate lying
& being in the Town of Richland County of
Oswego it being the South west corner of lot
twenty four in Scribner's Patent twenty first Township
containing twenty five acres to have and to hold
to my said son Benona and his assigns for ever

during the Term of his natural life without impeach-
ment or waste and from and immediately after
his decease I give and devise the same to my Grand
son Nelson Bennett Lorenzo Bennett and my four
Grand Daughters Mary Aurelia Emelia and
Laisa Bennett their heirs and assigns forever
I further give and devise to my son Reuben
Bennett his heirs and assigns all that certain piece
or parcel of land lying and being in the Town
of Richland in the Twenty first Township of Scribner's
Patent known at the east part of Lot number ten
containing eighty four acres as well more fully
appear on reference to a deed from Benjamin
Bennett and Patsy his wife to me the said
Roswell dated 21. May 1830

And lastly as to all the rest residue and remain-
der of my personal estate goods & chattels of what
kind & nature soever I give and bequeath the
same except my wearing apparel which I give
& bequeath to my son Oliver to my daughter
Lois Waller and Esther Barber. I hereby appoint
William Hale of the Town of Richland County
of Oswego and State of New York and Hiram
Hubbel of the same place Executors of this my
last will & Testament; hereby, revoking all former
