I hereby appoint Thomas Conover of the said town of Palermo Executor and my wife Lucretia Green Executrix of this my last will and testament, hereby revoking all former wills by me made.

I hereby authorize and empower my said executor and executrix to sell and dispose of all or any of my personal or real estate at public or private sale at such time or times and upon such terms and in such manner as to them shall seem meet for the purpose of paying the above mentioned legacies.
