That this deponent was present as a witness and did see the said Allen G. Patten subscribe at the end thereof the instruments now produced and shown to this deponent, purporting to be the last will and testament of the said deceased bearing date the thirtieth day of May in the year of our Lord one thousand eight hundred and fifty. That the said testator at the same time declared the instrument so subscribed by him to be his last will and testament. That therefore this deponent and Stanton S. Sibley of the town and County of Oscego subscribed their names at the end thereof as witnesses thereto at the request of the testator in his presence, and that the said testator at the time of executing and publishing the said last will and testament was a citizen of the United States of full age and of sound mind and memory, not under restraint or in all respects competent to make a last will and testament.

Be it remembered that herebefore tonight, in the 23<sup>rd</sup> day of August A.D. 1850 James H. Stewart appeared in open court before Orin H. Whitney County Judge of Oscego County as surrogate and made application to have the last will and testament of the real and personal estate of Abraham T. Lent late of Granby deceased, proved & on such application the said Judge did ascertain by satisfactory evidence who were the heirs and next of kin of the said deceased and their respective residences. And the said Judge did thereupon issue a citation directed to the said heirs and next of kin by their respective names stating their respective residences and requiring them to appear in this court before the said Judge at the house of Asa Phillips in Granby on the 5<sup>th</sup> day of Sept. then next. And on that day satisfactory evidence by affidavit was produced and presented of the service of the said citation in the mode prescribed by law and such proceedings were thereupon had after that the said judge took the proof of the said will hereinafter set forth upon the said 5<sup>th</sup> day of September 1850 and he adjudged the said will valid as a will of real & personal estate & the proofs thereof sufficient. which said last will and testament & proofs are as follows:

The last will and Testament of Abram T. Lent of the town of Granby in the County of Oscego Considering the uncertainty of this mortal life and being of sound mind and memory do make and publish this my last will and testament in manner and form following (that is to say)

First I give and bequeath unto my niece Stella Archer a sufficient amount of property for her comfortable support and maintenance during the whole of her life time

I further give and devise to my two Daughters Clarissa and Elizabeth Stewart their heirs and assigns all that Messuage or tenement situated on lot Number forty five in the original township of Hunibal now Granby in the County of Oscego upon which I now live. Together with the rest residue and remainder of all my personal estate Goods Chattels of what kind and nature soever after paying all just and lawful demands against me to hold to them the said Clarissa and Elizabeth their heirs and assigns for ever equally to be divided between them and I do hereby appoint John Bush of the town of Ira in the County of Cayuga and Francis East of the same place Sol Executors of this my last will and testament hereby revoking all former wills by me made.
