 said sum of four hundred and twenty five dollars
 and order to be paid to the said legatee within
 one year after my decease
 I give and bequeath to my wife
 Ann Reynolds aforesaid her heirs and assigns
 all that tract or parcel of land situate
 lying and being in the town of Westborough
 county of Orange State of New York being
 part of lot No. 20 bounded N. E. of
 Charles Patrick Robinson's lot 2 of said town
 beginning at the S. E. corner of said subdivision
 lot 2 and run from thence S 67 1/2° W 9 chs
 9 links along the S. E. and S. W. road to the
 S. E. corner of the widow Sally Shuman's farm
 thence S 22 1/2° E 19 chs 7 1/2 links along the said
 widow Sally Shuman's farm to a stake in the S. W.
 corner of said lot thence S 67 1/2° E along the westerly
 bounds of said lot to a stake thence S 22 1/2°
 W 19 chs 7 1/2 links to the place of beginning
 containing 19 acres of land more or less together
 with all the improvements and appurtenances
 thereto to have and to enjoy or in any wise appertaining
 to her and to hold the premises aforesaid
 to the said Ann Reynolds her heirs and
 assigns forever And after her decease the
 residue if any I will and bequeath to my
 eldest daughter Emily Leamy

that I give and bequeath all the real estate
 and personalty of my real estate of every name
 and nature whatsoever to my said wife Ann
 Reynolds And lastly I give and bequeath
 all the real estate and remainder of my personal
 estate goods and chattels of what nature or kind
 soever to my said wife Ann Reynolds whom
 I hereby appoint sole executrix of this my last
 will and testament hereby revoking all former
 wills by me made
