years and being of sound mind and memory do make publish and
declare this my last Will and Testament in manner following:
That is to say

First I give and devise all my Real Estate in the Village of
Merced County of Orange and State of New York consisting
of a house and two lots due to me by Arnon and Eliza
Biddloom to Ebenezer A Bathum and George C Bathum
George C Bathum is to have the property by paying Ebenezer
A Bathum Two Hundred and Fifty dollar viz:
One Hundred dollar to Morgan S Bathum One Hundred
dollar to Salah A Bathum One Hundred dollar to Fanny
Mc Cobie One Hundred dollar to Mary Ann Bathum One
Hundred dollar to Francis A Philbrick Five dollar to Samantha
Hibbard Five dollar to Louisa Mc Veeb Five dollar to Eliza
Mc Biddloom Five dollar to the children of Sally Ann Lewis
deceased

I further give and bequeath unto Morgan S Bathum one lot
of land in Salkirk town of Richland Orange County State
of New York due to me by John Wood deceased

I further give and bequeath to Francis A Philbrick all the
household furniture except one table and one set of chairs
which I give to Mary Ann Bathum

I further give and bequeath after my deceased and my funeral
charges and Tomb stones are paid for and all my debts
cancelled the remainder to Ebenezer A Bathum George C
Bathum Mary Ann Bathum Francis A Philbrick to be
divided equally between them in the case of the death of
either one of the parties without him it is to be divided
between those living named as above

Now as this personal property is coming from Arnon Biddloom and
Eliza Biddloom in seven annual payments the first payment is
to Ebenezer A Bathum and Francis A Philbrick second payment
to Morgan S Bathum and George C Bathum third payment to
Mary Ann Bathum and Fanny Mc Cobie fourth payment to
Salah A Bathum and the remainder of the sum

I hereby appoint Arnon Biddloom Executors and Eliza Biddloom
Executrix of this my last Will and Testament hereby revoking all
former Wills by me made.
