Local and Miscellany.

Lud. Williams, of Throopsville, died this morning, at 8 o'clock.

E. L. Tremain, Overseer of the Poor elect, is to have his office on the corner of State and Clark streets.

R. R. Dennis, of the News, and wife left for Florida last evening, on a visit of some three weeks.

The Advertiser says, John M. Conger, Esq., of the 5th ward, last evening entertained a large party of friends in celebration of the election of Mayor Gallup.

Apparently, in the estimation of Ald Wood, retrenchment and reform, so far as the Printing is concerned, consists in changing the patronage from the News to the Advertiser. Under the circumstances, his great cry of reform will be estimated for what it is worth.

The Oswego Advertiser learns that several thousand bushels of wheat have been sold by farmers in the vicinity of Meridian recently, to Oswego millers, for \$1.20 per bushel, delivered at Lamson's Station, on the Syracuse & Oswego railroad. Some sales have also been made in Syracuse.

The two democrats in the Common Council, present on Monday evening, are classed by the Advertiser, one as being in favor, and the other opposed to reform and retrenchment. How is this, gentlemen? Did either of you vote for the News as official paper.

UNION.—On Sunday last, a Presbyterian and Universalist occupied the same pulpit, in Scipio. One preached in the forenoon and the other in the afternoon. They were apparently on the best of terms.

The Auburn Democrat was not complimented by a single vote for official paper, by the common Council, on Monday evening, although there are three democrats in the Board. One was absent being sick. This is none of our affair; but if we were publishing a Democratic paper, we should think our friends had turned a cold shoulder on us.

As the post office is soon to graduate on Exchange street, the dry goods store of Messrs Nye & Co. is preparing to return to its parent in Syracuse.

We are pleased to see that Alderman Brown, of the Third Ward, is classed by the Advertiser among the reformers in the Common Council. During the past year, we have thought several times we saw a disposition on the part of the Advertiser to pitch into the Alderman; but we feel re-assured, it is all right now. The only complaint we have to make against him, is, he didn't vote for the BULLETIN for official paper of the city.

The Port Byron Times copies our notice of the sleigh-ride of the First M. E. Church Sabbath School to Port Byron and adds:

"We are glad the children had a good time, and that their wants were properly attended to, notwithstanding the astonishment of the friends. But we would be very thankful to be informed what sort of a school it is and where located that 'Messrs. Charles Hayden, Nathan Manger and Dr. J. E. Chandler' represent, or are connected with, which was invited to visit Auburn."

You have us there, Mr. Times. We rather guess our reporter was treated so kindly, he thought they were all devout Methodists.

We learn from the Port Byron Times, that "the Sabbath Scholars of the second Methodist Church, of Auburn, visited that town last Wednesday and had a jollification at Masonic Hall. We are informed there were fifteen loads of them." Our friends in Auburn are anxious to know where this Second Methodist Church is located.

QUERY.—Did it occur to Ald. Wood, the "champion of retrenchment and reform," when he made his motion, on Monday evening "that scaled proposals shall be received from the proprietors of the Auburn Morning News and Auburn Daily Advertiser, by the Mayor, and there opened, and that paper designated as the official organ for the ensuing year which shall do the printing of the city the cheapest," that it was quite possible the News and Advertiser might present bids exactly alike? They may both offer to do it without charge! In that case which would become the official paper? Perhaps, however, our friend the Alderman, is too much a "novice" in such matters to think so far.

CITY DEBT.—By a balance sheet handed to the Mayor by the ex-Treasurer and Tax Receiver, it appears that the city is in debt nearly seven thousand dollars, exclusive of the checks that were ordered yesterday by the outgoing administration, amounting to about eighteen hundred dollars. What is still worse for the city, among its other resources, are reckoned over four thousand dollars of old assessments levied in 1867 and 1868, which will never, probably, be collected. Putting these down as bad accounts and adding the checks ordered yesterday it would appear that the city debt will foot up at least thirteen thousand dollars.—Adv.

The Postoffice in the village of Port Byron nearly became the beginning of what would have proved a large fire on Tuesday night of last week. Some one had been smoking cigars and threw the stumps—still burning—into a spittoon, which was simply a box containing saw-dust. The saw-dust ignited, but was not observed on shutting up the office. Next morning about four o'clock, Geo. Somers in passing the office, saw a light, and looking in at the window saw quite a little fire burning. He alarmed Mr. Hart, who entered and put out the fire. A hole was burned through the floor, and in half an hour the building would have been in flames; and with it must have burned Masonic Block.

ECONOMY IN THE CITY GOVERNMENT.—The Advertiser is gratified that a majority of the City Government are in favor of reducing expenses. It claims that "nine members of the Board are in favor of retrenchment and reform, and four in favor of compelling the tax payers to put their hands in their pockets to assist in supporting some news paper establishment." The four members mentioned by the Advertiser as opposed to retrenchment are, Messrs. Choate, Dunning, Palmer and Woodruff. We shall watch the course of all these gentlemen with great interest, now that we know who the reformers are. We can't exactly see it in the same light; but as the "champion" reformer is looking after the interests of the Advertiser, we suppose they must know whereof they affirm.

ACTION OF THE GENERAL TERM IN THE MATTER OF THE DEATH OF HON. GEORGE RATHBUN.—The March General Term of the Supreme Court for this District, commenced in Rochester, on Monday. President: Hons. Thomas A. Johnson, James C. Smith, and Charles C. Dwight, Justices.

At the opening of the Court, Warren T. Worden, Esq., arose and called the attention of the Court to the recent death of the Hon. George Rathbun, paying a high tribute to the deceased, and presented a series of resolutions which had been adopted at a meeting of the Cayuga County Bar, which he asked should be recorded upon the minutes of the Court.

We were present last evening, and heard the lecture by E. V. Wilson at Corning Hall. The speaker is a thick set, solid man, with evidently a good deal of energy and vigor in his physical organism, and about fifty or fifty-five years of age. He gave what we suppose he would call the philosophy of creation, in its progress from chaos up to man. We got but few distinct ideas from what he said; but we presume the fault was ours, and not the speaker's. We have not been sufficiently instructed in the Spiritual philosophy to comprehend its deep significance. It is no doubt, too, our fault that we are not taken with his manner of speaking. With a rough exterior, his mode of address was still more rough; and yet he advanced some shrewd thoughts, and we judge that he gave general satisfaction to the audience, not large but respectable for size, and destined to increase as he advances. The descriptive feature of the entertainment, at the close, excited a good deal of interest, but it will require time and careful inquiry, to decide as to its validity. It is not difficult to give descriptions of persons present, or their friends, which a little stretch of the imagination will conceive to be true. We want time and opportunity to talk with these people, and ascertain the facts for ourselves, before we decide. We can not help fearing that there is some deception about it. We advise people to attend, and ascertain for themselves, and when there, not say yes to everything the operator may propose, unless a yes is positively demanded. It is much easier for a person, particularly a woman, to say yes, when a no would be more to the purpose, than be put in a position of antagonism to the speaker, and throw discredit on his statements. But our business should be to search for truth, and be satisfied with nothing else, whether it please or displease.

Justice Johnson, on behalf of the Court, responded to the eulogies pronounced by the gentleman, and stated that the Court fully sympathized with the spirit of the resolutions, and could testify to the rare legal attainments of Mr. Rathbun, and proceeded to express the sorrow of the Court and deep regret felt at the great loss sustained by the profession, in his death.

Give Him a Fair Chance.

Ex-Alderman Gallup is the Mayor of Auburn. Every body says he was an excellent Alderman, and every body said he would make a good Mayor. There can be no doubt of this, whatever. It is a fact as well established as the fact that he is Mayor at all. And we hazard nothing in saying so.

This paper is independent of any and all parties, and so far as partisanship is concerned—neutral. It is at liberty to commend or condemn precisely whom or what, it pleases. Its principal aim, just now is to urge economy in the hard year of 1870, in every department of our government—national, state, county and city. It asks a return to prudence and economy in everything.

Taking this view of men and things, it asks a fair chance for Mayor Gallup to carry out, so far as he can, his own policy. It can scarcely be said that notwithstanding his standing as a Democrat, he was elected to his present office by the Democratic party. He was elected to it, in fact, by Republicans who had become disgusted and tired with the former management of our city affairs. By some of them, he was urged to become a candidate for that office; and the workmen's movement was suggested as a means to that end. As such, it forced the Democratic party to put him in the field. Once in the field, there were Republicans enough who kept an eye to results, to see to it that he went into the office.

It is not likely that Mayor Gallup will ever know by whose votes precisely he was elected. And we do not suppose it necessary, if we could, to inform him. Suffice it that he is there by the votes of a majority in a republican city; and that is enough for his purposes and the purposes of those who put him there. And that is enough for the text of this article. Eli Gallup is Mayor of the city of Auburn by enough of republican influence to accomplish that result. That is the accomplished fact, which warrants us in asking for him a fair trial. This he is entitled to, and ought to have.

In the appointment of his committees, in the appointment of his policemen, so far, and in his general deportment as Mayor so far, we believe he has given general satisfaction. What he may yet do, we do not pretend to know; but we feel warranted in asking for him a fair chance, to carry out his policy. GIVE HIM A FAIR CHANCE.
