

ON HISTORIC GROUND.

President Visits Cedar Mountain Battlefield.

BACK FROM A HUNTING TRIP.

Mr. Roosevelt hears the story of the extraordinary fight from the lips of one who took part in it—details of the day.

Washington, Nov. 2.—President Roosevelt has returned to Washington from his northern hunting trip. On his way home the president visited the battlefield of Cedar Mountain.

The president drove to the battlefield over the road which years ago was the stage route between New York and New Orleans. On arrival at the battlefield, which is dotted here and there by monuments marking the positions of the troops during the fight, the contest was explained to the president by Judge Grimley, who now is a member of the bench of this judicial circuit.

The judge was a captain in the Sixth Virginia cavalry and was a participant in the fight. The president, a cavalryman himself, was interested particularly in the account of the famous cavalry charge made during the battle of Cedar Mountain. The Union and Confederate cavalry met in a depression not far from Cedar Mountain. While the battle did not last long, it was brought on quite unexpectedly and was frightfully sanguinary, the losses on both sides being about 2,200. The president was notably interested in a monument erected last August on the anniversary of the battle by the survivors of the Twenty-eighth New York infantry, which lost in the engagement 60 per cent of its men, including nearly every commissioned officer.

Reception on Battlefield. In the very heart of the battlefield President Roosevelt held an informal reception. Many people had gathered from the surrounding country, and after Judge Grimley had described the battle the president received informally those who had assembled on the field. During the reception the president was photographed by Mrs. Francis Bodie of Culpeper both alone and in a group with Secretary Root, Secretary Cortelyou, Dr. Rixey and Judge Grimley. Subsequently the president was given a shell which had been dug up on the battlefield as a memento of his visit.

In the morning the president and his party attended religious services at the Baptist church of Culpeper, about five miles from the home of Representative Rixey. Until a short time before the services began it was not known that the president was to be present. No special services marked his presence. Subsequently the party took luncheon at the residence of S. Russell Smith, a brother-in-law of Dr. Rixey, who is treasurer of the county of Culpeper.

At night the president was again the guest of Representative John F. Rixey at his country home near Brandy Station.

Bad Fire at Larchmont, N. Y. New York, Nov. 2.—Fire at Larchmont, Westchester county, has destroyed a section of the business district and wiped out houses in which a dozen families lived. The estimated loss is \$75,000. The flames started in the grocery store of Quins & Quigley, a frame building. The Larchmont Athletic club, the Alexander and the Bull state and the J. C. Harding and the Montrose livery stables were burned.

Mistook His Son For a Thief. Richmond, Va., Nov. 2.—Mrs. W. S. McLane of Covington, Va., shot to death her son William, thirteen years old, whom she mistook for a thief. Late in the night Mrs. McLane heard some one moving around outside of the house. She called repeatedly, but the noise continued, and, fearing she was about to be attacked, Mrs. McLane fired a shotgun out of a window. She opened the door and found her son dead.

Big Locomotive Explodes. Baltimore, Nov. 3.—A 100,000 pound locomotive, drawing a freight train on the Baltimore and Ohio railroad, exploded at Hothorp, about seven miles from this city, where the Baltimore and Ohio tracks cross those of the Pennsylvania railroad. Portions of the boiler were lifted from the trucks and hurled 150 feet. Two men were instantly killed and another so badly hurt that he died in a few hours.

Four Killed at a Grade Crossing. Elgin, Ill., Nov. 3.—Frank and Louis Schaefer and Charles and James Woodrich were killed at Algonquin, Ill., when the milk express on the Chicago and Northwestern railway struck their carriage on the crossing of the main street of the village. The young men had started to drive to Dundee and did not see the train on account of the darkness and the cover of their buggy.

Fast Mail Wrecked. Charlotte, N. C., Nov. 3.—A through mail train on the Atlantic Coast Line railroad crashed into a freight train which was taking the siding at Elm City, N. C. Engineer W. W. Currie of Florence, N. C., was so badly injured that he died two hours later. A mail clerk also was injured. Traffic was blocked for six or eight hours.

Mr. Schwab Going to India. Genoa, Italy, Nov. 2.—Charles M. Schwab has gone on board the steam yacht Margarita and intends to sail for Cannes. Mr. Schwab is accompanied on board the Margarita by eight friends. He is in good health. After a short stay at Cannes Mr. Schwab will proceed for Bombay.

BOMB UNDER A HOUSE.

A Whole Family is Blown Up For Revenge.

Chicago, Nov. 3.—A dynamite bomb, the weapon of a deranged assassin, blew up the home of Joseph Kordeck in Chicago Heights, killing two members of the family outright and injuring several others. The house was set on fire and burned, while that of a neighbor caught fire and was also destroyed.

The dead are Joseph Kordeck, arms and legs blown off, and Lucy Kordeck, aged two years, both blown to pieces.

Mrs. Lucy Kordeck had the flesh blown off the right side and was in great agony. She may die. Seven children who escaped were injured, but not seriously.

The explosion occurred while the family was asleep. The father and mother, with the daughter Lucy, occupied a room in the front of the cottage. On the other side were rooms occupied by the rest of the family. The cottage stood two feet from the ground on wooden posts.

The bomb was placed under the room occupied by the parents, and the impact of the explosion tore a hole in the floor, blew the best to pieces, dismembered Kordeck and scattered into fragments the body of Lucy, who was sleeping with her parents. Pieces of flesh the size of a man's hand were the largest remnants of the child's body that could be found.

The force of the explosion was directly upward and tore a piece of flesh from Mrs. Kordeck's side and blew her through a window. The noise aroused the rest of the family, and they had hardly time to escape from the flames, which soon destroyed the cottage. Kordeck's body, torn to shreds, was found in the debris after the fire.

Charles Smith, a former boarder at the Kordeck house, who was paying attention to one of Kordeck's daughters, has been arrested, charged with the crime. The Kordeck girl was to have been married to another man next week. Smith declares he is innocent, but neighbors declare that he made threats to them that if the girl refused to be his wife he would blow up the entire family with dynamite. Smith was absent from his room at the time of the explosion. His roommate, Thomas Kobilinski, claims that Smith returned to his room greatly excited shortly after the explosion.

TROLLEY STRIKE SETTLED.

Men of Hudson Valley Railroad Go Back to Work.

Glens Falls, Nov. 3.—The Hudson Valley railroad strike has been settled by unanimous vote of the striking employees, the company accepting a proposition made by the men, who have returned to work. The union is not recognized.

A committee of the Glens Falls men called on President Colvin and General Manager Joseph and after a consultation was asked to formulate terms upon which the men would return to work. This was agreed on, and the committee submitted terms which, after some amendments, were accepted by the officials.

The men get a slight increase in pay, and all the employees except those under indictment are taken back. The men will form a new union, unaffiliated with any other organization.

Shot by Schoolmates. New York, Nov. 3.—Two Brooklyn boys are locked up in Raymond street jail, while a third is dying from a gunshot wound at the Kings County hospital. According to the parents of ten-year-old Eugene Steingemann, older boys have been persecuting him for some time and wound up by shooting him. Eugene is the son of Max Steingemann, an electrical manufacturer, who lives at 3418 Avenue G, Flatbush. The boy attends school at Newkirk and Nostrand avenues. He is a bright boy, more fond of study than of romping with his classmates. Because of this disposition Eugene gained the ill will of other boys.

Fatal Mine Explosion. New Straitsville, O., Nov. 3.—Maurice O'Brien, a miner; Charles Sampson, stable boss, and Herbert Coran, bookkeeper, have been killed by an explosion of gas in Lost Run mine, near here. It is supposed the gas found its way into the mine from an adjoining mine, which has been abandoned for several years. It is believed the men went in to explore the mine and that the gas was ignited by the lights they carried.

Wanted to Go to Sea. Annapolis, Md., Nov. 3.—The administration of Commander Richard Winwright as superintendent of the Naval academy has closed. He has left this city for Boston, where he will join the United States ship Newark, which will be the flagship of the Atlantic squadron.

Boy and Girl Killed by Train. Youngstown, O., Nov. 3.—Herbert J. Hoffman, aged twenty-two, and Florence Carroll, aged nineteen, have been killed by an Erie passenger train. The couple were out for a pleasure ride, and their carriage was struck by the train. Hoffman was the son of Fred Hoffman, a leading lumber dealer.

Brakeman Killed in Collision. Schenectady, N. Y., Nov. 3.—A freight brakeman was killed and a freight conductor slightly injured in a rear end collision between two freight cars five miles west of this city on the New York Central. The first train was running on schedule time and the second on caution orders.
