

### SCORE 60 FROM HERE TO REUNION OF 27TH DIVISION

Twenty veterans of the Twenty-seventh Division will leave the Army at 7 o'clock tomorrow morning in four automobiles for the trip to Saratoga where they will attend the first annual reunion of the division.

Mortimer Clark will take one party in his car, and Gen. Edgar S. Jennings, Lieut. Kennard Underwood and Lieut. William Williamson will furnish the other cars. If there are any others of the veterans who decide to go they can be accommodated if they show up at the armory tomorrow morning. The party will arrive in Saratoga tomorrow night and take up their quarters at the Continental Hotel.

Capt. W. L. Hodder and other delegates now attending the convention of the American Legion in Albany will proceed to Saratoga and it is expected that Auburn will be represented by 30 at the reunion. The sessions will last two days and the Auburn delegation will leave Tuesday afternoon so as to be back home that night.

Saratoga Springs, Sept. 11.—Veterans of the World War who were members of the Twenty-seventh division, composed of New York State National Guardsmen were arriving today for the first annual reunion to open tomorrow night and continue three days.

Speakers on the program tomorrow night will include Secretary of War Baker, Senator James W. Wadsworth, Major General George W. Read, U. S. A., who commanded the second corps, A. E. F.; and Brigadier General Edward M. Lewis, U. S. A., former commander of the Thirtieth division, which with the Twenty-seventh division, constituted the second army corps serving with the British armies in Flanders and Picardy.

### AUTO CLUB GIVES ROAD CONDITIONS

The following road information has been given to the Auburn Automobile Club by J. Charles Dayton, superintendent of highways for Cayuga County:

The West Lake road in the Town of Fleming between Norwood and the stone school house has been finished and is open to a point two miles south of Wyckoff's, where the road is closed in the Town of Scipio for construction.

The state road between Cato and Victory has been oiled and should be avoided for at least 10 days. The county is oiling the Victory-Red Creek road and also the Victory-North Victory road and should be avoided for one week.

Next Tuesday the road between Meridian and Jordan will be oiled and should be avoided for a week. Franklin Street between the city limits and Soule Cemetery is tightly closed.

In the Town of Leyard, the road between Poplar Ridge and Aurora is closed from Chapel Corners to the Cayuga Lake road.

The Posterville road in the Town of Aurelius and Montezuma is now open its entire length from the Clark Street road to Montezuma.

Next week the road between Senett and Weedsport will be closed for construction.

The East Lake road along Owasco Lake is closed in the Town of Niles and Moravia beyond Koenig's Point and will be closed for at least one month longer.

The East Lake road along Cayuga Lake between Union Springs and Levana is closed for construction. The plan is to complete from the south end of Union Springs to the Farley's Point road, Saturday, Sept. 11, and then allow travel over the Big Gulley road northerly along the lake road to the Farley's Point road.

The road from Victory Village south to Conquest, which has been closed for the last month, will be finished and open by the middle of next week.

All other main roads are open and in good condition. Dated Sept. 11, 1920.

### TOM BROWN DAY TO BE CELEBRATED

Immediately after the reorganization and reinstatement of the Mutual Welfare League of Auburn National, preparations were begun for the celebration of Tom Brown Day which falls on September 25. This is the one great anniversary in which all inmates of the prison in good standing join whole heartedly. It is in honor of Thomas Mott Osborne who as Tom Brown shared the lot of the convicts for one week nearly seven years ago and as a result founded the Mutual Welfare League.

Mr. Osborne has each year since then been the guest of honor on the anniversary of his voluntary incarceration and he will be on hand for the coming celebration. Secretary William M. De Maio chosen by the Board of 11 directors of the league last Monday is already busy with his plans and Warden Jennings will permit as much latitude to the inmates as is consistent with the state of probation that now obtains in the prison.

There will be a program of sports and there will be entertainment in the chapel with speeches by Tom Brown and others. A special feed will be provided and the day will be much the same as the other anniversaries of Tom Brown Day in the past. There will be prizes for the winners of the track and athletic events, and in the depleted state of the league treasury a plea is sent out for donations of cigars, tobacco, socks, handkerchiefs and candy.

### AUBURNIANS WILL ATTEND UNVEILING OF MONUMENT

On Saturday, September 18th, at 2:30 p. m. the Monument which the Order of the Eastern Star has erected at the Eastern Star Home, Oriskany, N. Y., in honor of the memory of the members of this organization who lost their lives in the World War will be unveiled and the Memorial Tablet in connection with it will be dedicated. All members and visitors are to assemble at the Home at 2 o'clock and go in a body to the cemetery, a very short distance, where the ceremonies are to be held. This monument was procured from voluntary donations received from the Chapters and individual members, throughout New York State.

### HIGHER MOVEMENT IN STOCK MARKET

New York, Sept. 11.—Pronounced improvement in investment conditions as evidenced by the success attending the new French loan offering and a growing conviction that the credit situation is relaxing were the propelling forces of a fairly active and irregularly higher movement in the stock market this week.

Bonds also were stimulated by the ready absorption of the French issue, excepting the Liberty group Anglo-French 5's. Swiss 5's and other international war notations made variable advances on a broader demand.

The recent inquiry for low priced speculative rails was less marked, notwithstanding the more encouraging crop outlook, especially as to corn. Standard rails, notably Pacific and coals, continued to strengthen on further accumulation, apparently by substantial interests. Steels, equipments and related shares frequently were overshadowed by the activity of oils and shippings, but motors and their subsidiaries were under occasional restraint as a result of less favorable trade advice. Money and foreign exchange pursued widely different courses, greater ease being evinced in the rates of time and demand loans, while remittances to London fell to lowest levels in almost five months, with concurrent heaviness in quotations on continental European points.

### CHARGE SYRIAN WITH STEALING RUGS FROM PLANT

Ella Nicholas, 39, born in Syria, was arrested by the police shortly before 11 o'clock last night near the plant of the Fifth Carpet Company, charged with the theft of rugs owned by the factory.

The Syrian had been employed by the concern for some time. Suspicious actions were noticed and last night the police were sent for. Sergeant Greene and Patrolman Falcone were detailed. When walking about the north side of the Fifth Plant they saw a bundle being eased out of one of the windows to the ground.

The cops secreted themselves and when the bundle was followed by the Syrian and he had started away with the rugs, he was nailed and brought to headquarters. In the bundle were five small rugs.

Then Recorder Wright was sent for and he issued a search warrant for the premises of Nicholas at No. 10 South Division and a number of rugs and other paraphernalia of a similar character were brought to the hall. One parcel was a big house rug.

Representatives of the carpet company are looking over all of the rugs at the City Hall in order to make sure that same were sold by the concern or had been stolen from the plant.

After Nicholas had been arraigned and mugged for the police gallery, the case was adjourned to September 13.

### CURTIN NAMED TO POLICE FORCE

City Manager John P. Jaekel this morning appointed P. J. Curtin of No. 2 Camp Street a patrolman in the police department, to fill the vacancy caused by the recent resignation of Patrolman Michael Ryder. The appointment is effective September 20. Curtin stood at the head of the recent eligible list certified by the Municipal Civil Service Commission, is a former service man and should prove an excellent officer.

### TROLLEY KICK NOT TO HALT ORCHARD STREET PAVING

The refusal of the Empire State Railroad Corporation to change the grade of tracks in Orchard Street and the announced intention of abandoning the Orchard Street trolley tracks will not delay the progress of the Orchard Street pavement for which Brayer Brothers have the contract.

When the pavement progresses so that the tracks have to be changed the work will be done by the city and a bill turned over to the trolley owners for payment. Settlement, if necessary, will be carried to the courts.

### TRADE HEAVY ON PUBLIC MARKET

The Saturday Public Market this morning saw 65 rigs loaded to the top with fresh produce and a large gallery of patrons. There was little change in prices which have prevailed all week. The quotations:

Corn, 10 and 12 cents per dozen; butter, 60 cents per pound; eggs, 60 and 65 cents per dozen; beans, 25 cents per peck; tomatoes, 60 cents per basket to \$1.10 per bushel; lettuce, two heads for five cents; squash two for five cents; Swiss chard, five cents per bunch; string beans, five cents per quart.

Live chickens, 35 cents per pound; dressed chicken, 45 cents per pound; broilers, 40 cents per pound; duck, 33 cents per pound; peas, 75 cents per peck; plums, 75 cents per basket and \$1.50 per bushel; pears, \$1 and \$1.25 per bushel; apples, 80 cents to \$1 per bushel; dry onions, \$1.50 per bushel; turnips, \$1 per bushel; potatoes, \$1.10 to \$1.50 per bushel.

Dry beans, 15 cents per quart; onions, five cents per bunch; cabbage five to 10 cents per head; home grown watermelons, 50 cents each; cantaloupes, 15 to 50 cents each; elderberries, 10 to 12 cents per quart; carrots, five cents per bunch; celery, five to 10 cents per bunch and 60 cents per dozen.

Cauliflower, 10 and 15 cents each; peppers, 15 to 30 cents per dozen; broccoli, five cents per bunch; crab apples, \$1.25 per bushel; cucumber pickles, 40 to 50 cents per hundred; cucumbers, one cent each; egg plant, 15 cents each; pumpkins, five and 10 cents each.
